General Terms and Conditions — Travel Diary

Effective: 08/01/2026

1. Operators of the Service

The Travel Diary application ("Service") is developed and operated jointly by Stecenkó Martin and Molnár Milán, private individuals ("Operators").

The Operators currently do not have an independent business entity form; at this stage of the Service, they operate it as private individuals, as an early-stage development project. Should demand for the Service justify it, the Operators reserve the right to establish a business entity, in which case these Terms and Conditions and the Privacy Policy will be updated, and Users will be notified electronically.

2. Description of the Service and Pricing

2.1. In its current (first) version, Travel Diary is a **free** web application that allows registered users to document their trips by recording address, location, dates, description, and photos.

2.2. The Operators reserve the right to offer certain features or tiers of the Service introduced in the future (e.g., expanded storage, additional features) as part of a paid subscription package.

2.3. In the event that the currently free basic features (recording trips and photos, basic sharing function) become subject to a fee, the Operators will notify all affected Users in advance, electronically (at the email address provided at registration), giving the User a reasonable period to make a decision (e.g., exporting their data, deleting their account, if they do not wish to use the paid service).

2.4. If a paid package is introduced, its exact price, content, and payment terms will be published separately, as an amendment to these Terms and Conditions, and submitted to Users for acceptance.

3. Registration and User Account

3.1. Use of the Service requires registration, which is done by providing an email address, password, display name, and unique username.

3.2. The User is responsible for keeping the password associated with their account confidential, and for all activity carried out through their account.

3.3. The User is required to provide a real email address that they actually use.

3.4. The Operators reserve the right to suspend or delete an account in the event of signs indicating misuse (e.g., automated registration, misuse of another person's identity).

4. User Content

4.1. With respect to content uploaded by the User (text, photos — "Content"), the User warrants that they are entitled to upload it, and that it does not infringe the rights of any third party (e.g., copyright, personality rights, other persons' rights to their own likeness).

4.2. By uploading Content, the User does not transfer ownership of the Content to the Operators; the User only grants the right for the Content to be stored and displayed to the extent necessary for operating the Service (in the User's own account, or, in the case of an actively shared public link, via that link).

4.3. The Operators are entitled to remove any Content that violates the law, or that is reasonably suspected of infringing the rights of a third party.

5. Sharing Function

5.1. The User may choose to make a given Trip available to third parties without registration by creating a unique, public link ("Shared Link").

5.2. The Shared Link grants only viewing (read-only) access; the holder of the link may not edit or delete the Content.

5.3. The User may revoke the sharing at any time, after which the link immediately becomes invalid.

5.4. The User is responsible for ensuring that they have the necessary consents for publishing the shared Content (including any other persons who may appear in it).

6. Availability of the Service

6.1. The Service is currently provided free of charge, on an "as-is" basis — see Section 2 for details on future pricing plans. The Operators do not guarantee uninterrupted or error-free operation of the Service.

6.2. The Operators reserve the right to modify the Service, or to expand or discontinue its features, subject to prior notice where reasonably expected.

7. Limitation of Liability

7.1. To the fullest extent permitted by applicable law, the Operators exclude liability for indirect or consequential damages arising from use of the Service.

7.2. The Operators assume no liability for the loss of Content uploaded by the User in cases reasonably beyond their control (e.g., a malfunction of the hosting provider).

7.3. It is recommended that the User make their own backup copies of any Content that is important to them.

8. Account Deletion

8.1. The User may request the permanent deletion of their account and all associated data (Trips, photos) at any time, at the email address traveldiary.app.team@gmail.com.

8.2. Deletion is permanent and irreversible.

9. Intellectual Property

The software, design system, and brand name of the Service constitute the intellectual property of the Operators.

10. Governing Law

These Terms and Conditions are governed by Hungarian law.
